- ✓ For family members on 11-12-2022 at 9.00 am at Karnataka Government Secretariat (KGS) Club, Cubbon Park, Bengaluru.

Rules and Regulations from the Tournament panel:

- 1. In case of any dispute during the match, it shall be resolved by the organizing panel and team captains only. KSCAA organizing committee's decision shall be final in case of any issue or concerns and no objection whatsoever shall be entertained.
- 2. The decision of the umpires/referee stands final no objection whatsoever shall be entertained. The excessive appeal is restricted.
- 3. The participants are requested to bring their own kits. Only shuttles will be provided by the organizers. The facility of rentals if any will be at the price of participants only.
- 4. Mavis 350 or the nearest variant of the shuttle will be used for all the games irrespective of the categories.
- 5. The players have to report at the venue by 8.30 a.m. and be present at the venue throughout the tournament. The players not available on spot within 5 minutes of the call will be given a walk over and games will move to the next level. Each game time will depend on the completion of the previous event/game in the sequence. The players must co-operate and wait till their turn. In other words, the opponent/opposition team shall be declared as the winner in case any participant/team reports beyond five minutes after the scheduled time of commencement of their respective matches.
- 6. Lunch will be served from **1.30 pm to 2.30 pm**. The lunch facility is provided by the organizers at the premises itself.
- 7. The Organizers have the right to change/modify the rules and regulations.
- 8. Only **KSCAA** Members **having membership numbers** can participate in the tournament, nonmembers are not allowed strictly. Members are expected to carry valid proof to prove membership. In case, at a later stage, we get to know about any member not having KSCAA membership, the entire team will be disqualified.
- 9. The age of members will be reckoned as on the date of the tournament. Each one must carry their proof of date of birth.

- 10. Minimum of 6 teams should be registered and present in the court to conduct each event. In the absence of the required team threshold, the event will not be conducted. If the required number of participants is not present, the decision on cancellation will depend on spot registrations, if any, as decided by the organizers.
- 11. The players in the higher age category are allowed to play in one of the lower age categories or the category matching his age. This is applicable in both Singles and Doubles games.
- 12. Rules from the Badminton Court are given below. Non-adherence of rules might result in disqualification.
 - a. Only Sportswear is allowed like T Shirt and Shorts, Jersey and Track pants.
 - b. Non-marking badminton shoes are compulsory, preferably with a light-yellow sole. If any objection to this from court authorities the team will have to arrange the required non-marking shoes. Barefoot (without shoes) play is prohibited.
- 13. The match points and matrix will be decided by the organizers based on the number of entries. Organizers have the final right to decide on fixtures, rules or any other matter if it deem it fit without assigning any reason. The committee reserves the right to modify the above rules, if warranted.
- 14. Family for the purpose of this tournament means a CA member, his / her parents, spouse and children (up to the age of 15 years).
- 15. Family members' events are exclusively for non-CA members. CA must participate in CA member categories only.

Note: Rules are mandatory and breaking rules will be strictly prohibited and the participant / team will be disqualified.
